Corporate Membership Terms and Conditions

1) Must purchase minimum number of memberships. Guests are per day not per employee.

For example (note examples do not include sales tax):

- \$1,900 Sole proprietor and one guest
- \$2,850 Two employees and two guests or three employees with one guest
- \$4,275 Four employees and two guest memberships
- \$5,700 Four employees with four guests, five employees with three guests or six employees with two guest memberships
- 2) Employee's names must be listed on the application to qualify for Membership privileges, see below. Any named employee can bring the number of guests the plan allows per day, see examples above. Additional guest will receive the Member Guest green fee discount. Guest(s) must be accompanied by a named corporate member.
- 3) Tee times are required and can be made up to 10 Days in advance.
- 4) Trail Fee can be added to a membership, includes use of a club cart, tournament carts are excluded, cart must be turned in a the completion of the 9 or 18 hole round. Trail fee is specific to an employee and is not to be shared with the group. Guest of an employee with Trail Fee privileges rides for free.
- 5) Payment must be made by corporate check or credit card (3% service fee will be added for credit card payments).

Membership: Includes unlimited play with restrictions, tee times are required* and can be made up to 10-days in advance, voting rights at all Membership Meetings, eligible access to all club tournaments, free golf to minor children when playing with the Member listed on this application. Amenities such as carts, food, beverage, tournaments are at additional cost when available. Membership Fees are subject to Special Assessments if required. Note: Minor children play free when playing with the adult Member. If children will be playing alone, or with other members, then a JUNIOR 17 AND UNDER membership must be purchased. *Walk-on play is allowed subject to approval by the Pro Shop. Please check in.

<u>Dress Code</u>: Standard golf attire preferred - jeans permitted; no tank tops, cutoffs, tee shirts, short shorts or gym shorts.
